

### Security

All condominium staff have been instructed to be vigilant. Please accept, in your own interest, the various checks they have been asked to carry out. Please do not hesitate to report any suspicious incidents.

### Traffic / Parking

Please respect signs and road markings. Vehicles must travel at a very low speed (5 km/h) in covered parking areas. On all traffic roads, speed is limited to 10 km/h.

Car parking spaces in communal garages may only be used to park cars or 2-wheelers. For safety reasons, boats (even small ones) and any other objects may not be parked in the parking lots. All renters must use the garage or parking space normally allocated to the owner. Motor vehicles may not be parked on the driveways or manoeuvring areas. Motorcycles, mopeds, scooters and other noisy vehicles are prohibited during the summer season, from June 15 to September 15, from 11 pm to 8 am, with the exception of electric vehicles. We remind you that all vehicles must be insured (even when parking). Disabled persons must bring their disability card with them to Port-la-Galère. It is not the responsibility of the condominium management to issue any authorisation in this respect.

The use of scooters (adult or child) is forbidden on the estate.

### Electric car charging

For reasons of safety and integrity in the use of common property, fast-charging stations have been installed in the upper parking lot of the Port and opposite the 7 avenue de la Réale grappe. Charging cards are available for purchase at the Club d'Hiver reception, at a cost of €19.90.

Please note that it is strictly forbidden to use communal electrical outlets, whether indoors or outdoors, to recharge electric or hybrid vehicles.

### Animals

Dogs and cats are authorised on condition that all measures are taken to avoid any noise disturbance and that cleanliness is maintained. They are not allowed in restaurants, swimming pools or on the beaches. Dogs must be walked on a lead to the dog park when out and about. Generally speaking, all other animals are prohibited.

Dog waste bags are available at reception and at various locations on the domain. Please clean up after your pet.

### Noise and neighbourhood disturbances

Picnics, noisy or dangerous games and pets are strictly forbidden on the beaches, by the sea and at the Club d'Été swimming pool. Audio equipment and hi-fi systems are prohibited in public area (beaches, pools and gardens). The engine of a stationary vehicle must be switched off (to avoid pollution). The use of horns is prohibited inside the condominium.

### Window / Balcony / Terrace / Private garden

Laundry may not be hung on windows, balconies or terraces visible from the outside. Balconies and terraces may under no circumstances be used as rubbish dumps. It is forbidden to place reed screens or any other material along railings, balustrades, handrails and sills of windows, balconies and terraces (including planters outside balconies), as well as to use barbecues. Some private gardens are maintained by the condominium's gardeners. Tenants are therefore required, at the owner's request, to allow the passage of the staff for routine maintenance.

### Household waste

A binstore is located near to your apartment for your waste disposal. Three garbage bins are available: the grey bin for household waste, the green bin for glass containers and the yellow bin for loose packaging (cartons, cardboard, plastic, metal).

Using garbage bins is as much a question of respect for others, community premises and environmental protection as it is... hygiene!

### Club d'Hiver pool

The Club d'Hiver swimming pool is open from 8:00 am to 6:30 pm. Swimming is unsupervised. Noisy games are strictly forbidden, and children must be accompanied. For everyone's well-being, please respect the rules posted at the entrance. Sunlounger and parasol hire is €5 per unit in July and August. Only guests with sunloungers are allowed to use the lawns.

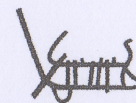
### Club d'Été pool

The Club d'Été pool is open from 8:00 am to 6:30 pm. Supervision is provided from 9 am to 12 pm and from 1 pm to 6 pm from July 01 to August 31. Deckchair and parasol hire is €5 per unit in July and August. Please note that deckchairs are allocated on arrival and cannot be reserved.

### Beaches

The buoys and floating pontoon are in place from June 15. Sunlounger service and surveillance are available from July 1 to August 31, 9 am to 12 pm and 1 pm to 6 pm. Sunlounger and parasol hire is €5 per units in July and August.
